

Overview

WWL efficiently delivering a safe, reliable, resilient and fit for purpose Waimea Community Dam

- ✓ Construction: Embankment and spillway completed. River diversion underway. ~85% complete, slowing
- ✓ Commissioning: All Crown and consent requirements met, other than building code requirements (88b)
- ✓ No serious harm injuries and full compliance with resource consent requirements.
- Mitigating part of project delay for Oct / Nov 2023 completion
- Further \$3M cost increase to **\$198.2M** driven by delay and M&E / diversion works, dispute costs
- Operating budget increase driven by insurance increase. To be worked



Progress Update: Embankment complete

- ✓ Completed embankment in Dec 2021
- ✓ Completed concrete face in May 2022 and parapet wall in August 2022
- ✓ Completed dam face pipes, rails and screens in September 2022.
- ✓ Commissioned winches and screens in October 2022





Progress Update: Spillway completed

- ✓ Spillway chute completed August 2022
- ✓ Ogee-weir completed October 2022
- ✓ Grouting concluding March 2023





Progress Update: Spillway

- ✓ Cut-off wall beneath spillway completed March 2023
- Apron to spillway approach channel delayed until May 2023 but won't impact project



Below spillway: Cut-off wall protects spillway from erosion



Above spillway: Grout and apron protects spillway seepage

Milestone: Closed LHS culvert and commenced diversion

- ✓ Closed left hand culvert with stoplog:
- ✓ Stainless steel lobster-back pipework bend installed and concrete plug:
- ✓ Installed temporary river diversion pipe (steel and HDPE) in LHS culvert:
- Delay to completing diversion and closure, to complete Contractor QA:








Programme Delay

- ❖ Closure and filling delayed until ~ 1 May 2023 to complete Contractor QA documentation & TDC Code of Compliance
- Increasing weather risk to closure as move into Autumn / winter.
- Practical Completion delayed until late 2023 with large and concerning prolongation of mechanical works (X4) (addressing)
- ✓ Expect reservoir to be full and providing service for 2023 / 2024 summer season



Operating cost forecast

Operating cost forecast + \$0.8M

- 110% increase in insurance (\$1.4M)
 To consider risk balance
- Rates increase (\$0.4M)
- Inflation

Finance costs + \$0.8M

- TDC Debt (to self)
- Increase project costs / new funding arrangement
- Higher interest rates

Residual Risks

- Project cost based on currently known costs and risks
 - Reasonable estimate of known risks and trends
- Cost forecast excludes un-quantifiable risks / unallocated contingency
 - Now mainly excessive weather
- Contractor claims and dispute costs
 - Contractor disputing Independent Engineer decisions
 - Contractor unsuccessful with claim through
 Adjudication under Construction Contract Act 2002
 - Contractor now proceeding to arbitration
 - WWL planning for 2+ years of dispute. Preparing.








